**NOTICE OF PRECAUTIONARY BOIL WATER ADVISORY**

Clearford Waterworks Inc has issued a Precautionary Boil Water Advisory effective immediately for users of the drinking water system. The Operating Authority, Clearford Waterworks, is undertaking corrective actions under guidance from the Ontario Ministry of Health (your local Health Unit) and in accordance with Ontario Regulation 170/03.

<p><b>Recommendation:</b> The water should not be used for: drinking, preparing food, oral hygiene, washing/rinsing cutlery, dishes, glasses and cups, and bathing young children (who sometimes drink bathing water) making infant formula and juices, making ice. For these purposes, boiled water or bottled water should be used. The elderly, infants, and those with weakened immune systems may be at greater risk.</p>	
<p><b>What should you do?</b></p>	
<p>Bring your water to a rapid boil for at least one minute (or you may use bottled water) and allow it to cool before using it to:</p> <ul style="list-style-type: none"> <li>• Drink</li> <li>• Gargle, spray or brush teeth, or rinse dentures</li> <li>• Wash fruit, vegetables, and other food; and</li> <li>• Make ice, juices, puddings, or other mixes</li> <li>• Baby food or formula should be prepared using only bottled water</li> </ul>	<p>Dishwashing:</p> <ul style="list-style-type: none"> <li>• Wash your dishes in a soapy solution, rinse and place them in a half-filled sink of water with two tablespoons of household bleach. Let dishes air dry. Households with a hot/sanitizing cycle may be used; they safely disinfect dishes.</li> </ul>
<p>For bathing and washing:</p> <ul style="list-style-type: none"> <li>• Adults, teens, and older children can still use tap water for baths and showers.</li> <li>• Young children can be given sponge-baths instead of tub baths or showers</li> <li>• Do not swallow any tap water used for showers and baths</li> </ul>	<p>If you or someone in your family becomes ill, you should:</p> <ul style="list-style-type: none"> <li>• Immediately obtain medical advice for the elderly, infants, and those with weakened immune systems</li> <li>• For others, obtain medical advice if diarrhea persists for more than 48 hours</li> </ul>
<p>Laundry:</p> <ul style="list-style-type: none"> <li>• Do laundry as normal</li> </ul>	

**The Precautionary Boil Water Advisory will remain in effect** until corrective actions have been completed and satisfactory microbiological testing meets the regulatory standards. Once the conditions are met, the advisory will be lifted. At that time, users will be notified that the conditions that led to the issuance of the advisory have been successfully addressed, and that normal use of the water can resume.

## Community Update

We are currently working to restore water service. When we attempted to turn the water back on, a transformer unexpectedly failed.

An electrician is on-site now and is actively working to resolve the issue. Once the repair is complete, we will be able to restore water service to the community.

**Please remember that the community remains under a Boil Water Advisory until further notice.**

All water intended for drinking, cooking, brushing teeth, or washing food should be brought to a rolling boil for at least one minute before use.
